The Rotary Foundation Corner

April 10, 2017

The Objective of The Rotary Foundation is the achievement of World Understanding and Peace through International Charitable and Educational Programs.

How is The Rotary Foundation Funded?

TRF is funded by the contributions we Rotarians make to it. We can make either **Designated** or **Undesignated** donations – the latter is what we make to the **Annual Fund–Share Program** when we become a Paul Harris Fellow or make the contribution in a named designee. Donations made to the **Annual Fund–Share** are split 50%/50% between our **District Designated Fund (DDF)** and **TRF World Fund** – hence the name **Share** – and returned after three years. 2% of the donation goes towards administration costs; the funds are invested for the three years and the interest earned pays the rest of the administration costs. **Designated** donations are those that are specifically designated to **Polio Plus**, **One Drop** or the **Permanent Endowment Fund**.

What does the District do with the District Designated Fund?

The **DDF** is used for **District Grants** – Block grants that enable Clubs and Districts to address immediate needs in both our communities or abroad. The DDF can also be used for **Global Grants** – grants that fund large-scale international humanitarian projects that have a budget of \$30,000 or more, and involve another Club or District in the recipient country. They may also be used for Vocational Training Teams or scholarships that have sustainable, measurable outcomes in one or more of Rotary's areas of focus.

What does The Rotary Foundation do with the funds deposited to The World Fund?

The funds that are deposited into TRF World Fund are used by TRF to match grant requests from Districts around the world, or go towards Packaged Grants, which are predesigned projects developed by TRF and its strategic partners, which are organizations that work in one or more of Rotary's areas of focus and offer financial support, technical expertise or advocacy.
