## ANNOUNCEMENTS

**Pres. Bruce** began by welcoming everyone as we start a new Rotary Year. He said that **RI Pres. Stephanie Urcheck** has selected “The Magic of Rotary” as her theme for the year. He said that he and **Rebecca** plan to make that our theme throughout the year, particularly with our next Gold Raffle.



Since we have a number of new members, he took a few minutes to introduce himself. He described himself a “gypsy” since he has lived in 20 cities and has traveled to 46 states with only North Dakota, Idaho, Montana and Alaska to go. He spent 40 years in hospitality, primarily food and beverage in hotels, convention centers, arenas, theaters, and catering. A key career highlight was spending 6 months in Fiji. He also opened the San Diego Convention Center. He told the story of a time when he and his dad were in San Francisco for an interview at Stanford. However, a trip down Hyde Street on a cable car was interrupted by a broken cable which sent them careening into a car and on down the hill. They had been headed to a Japanese Restaurant so they continued there and were met by the owner who took his dad into the restroom and put some bandages on a couple of minor wounds on his head (**Pres. Bruce** said the owner had been a medic for the Japanese during World War II.) He decided to go to Cornell University and study engineering but didn’t like it. Those were tumultuous years, including a “takeover” of the student union by some radicals and he woke up one morning to an FBI raid resulting in the arrest of one of his dorm mates who was associated with the “SDS” (Students for a Democratic Society). Later he happened to see a Time magazine cover with a picture of the arrestee who had no shirt on but did have a couple of “bandoleros” of ammunition crisscrossing his chest. He said there was another young man in the picture who he realized was his freshman physics lab partner.

**Pres. Bruce** said he has been married to **Kim** for 35 years and has one daughter, **Katie**, who recently retired after 10 years in the Navy and one son, **Scott**, who lives in Tennessee and is an electrician. He spent 10 years as a member of the Rotary Club of San Jose and has been a member of Southwest Rotary for 4 years.

**Pres. Bruce** then made the following announcements:

1. He has selected **Jordana Lane** as his presidential adviser and said that her connections with the district and with other clubs was a key consideration as he would like to partner more with other clubs during the upcoming year.
